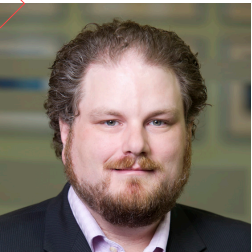
**Rhonda Small, FMP | Director of RSP | i\_SPACE**
